During the transit period, the Board of Governors managed the affairs of NMC and from time to time they nominated their members as representative. Subsequently, after enactment NMC came in full form but in spite of repeated requests, it has not nominated any one to represent in the Committee, rather expressed their inability vide letter dated 16.10.2020 to nominate any Member. Thereafter, vide letter dated 20<sup>th</sup> October, 2020 stating the legal mandates-as appeared from the order of the Hon'ble Supreme Court the NMC was requested to

nominate some one as its representative in the Committee followed by several reminders but till date there is no response.

In view of the above, it is resolved that the Committee may proceed on ad hoc basis and the authorities of N.M.C. be again requested for the needful. Simultaneously, the State Government be also requested to take immediate step in the matter. Further the Principal Secretary, Department of Health, who is participating as Member-Secretary, has also assured to do the needful immediately.


(i) The concerned proceeding is also hereby confirmed.
