

Proceedings of the meeting of the Educational Fee Fixation Committee held under the Chairmanship of Justice Akhilesh Chandra (Retd.) on 26.12.2020 at 11.30 A.M. in presence of the following Members:-

Agenda wise following resolutions are taken:-

Agenda No.1:-

Confirmation of the proceedings of the previous meeting dated 22.12.2020.

The proceedings of the previous meeting dated 22.12.2020 are confirmed.

Agenda No.2:-

To hear the authorities of the respective Medical Colleges, namely, (i) Madhubani Medical College, Madhubani, (ii) Netaji Subhas Medical College & Hospital, Bihta, Patna and (iii) Lord Buddha Koshi Medical College & Hospital, Saharsa at 11.30 A.M, 12.00 noon and 12.30 P.M. and for further needful.

During hearing at the schedule time, the representatives of all the three colleges respectively appeared before the Committee and submitted the revised proposals, which have been on overall consideration accepted. Accordingly, for Madhubani Medical College, Madhubani, Rs.13,50,000/- for Indian residents and for NRI 25,000/- USD, Netaji Subhas Medical College & Hospital, Bihta, Rs.15,50,000/- and 35,000/- USD and for Lord Budha Koshi Medical College & Hospital, Saharsa, Rs.12,00,000/- and 25,000/- USD have been fixed.

The Committee after overall consideration, including the effect ongoing Pandemic accepted the revised proposals for Under Graduate course for the batch 2020-21 for the period 4.5 years per annum, excluding hostel, transport and mess charges on ad hoc basis with specific direction to submit the

audited financial statement for the year 2019-20 and all relevant Form-16 and compliances related to TDS and other compliances by 15th March, 2021, failing which the fee so fixed may, accordingly, be decreased.

The Committee further directed that the Institution shall not charge either directly or indirectly any other amount over and above the amount fixed as fees. If any other amount is charged under any other head or guise e.g. donations, fee by any other name, the same would amount to charging of capitation fee. Any deviations of this order of the Committee will invite serious penal consequences.


It is made clear that since the colleges have been granted permission for intake of the students of the batch 2020-21 for the academic year 2020-21 only the above fees have been fixed only for the said batch 2020-21 for a period of 4.5 years. The colleges are expected to come with the proposal and relevant supporting papers in the event the permission being granted by N.M.C. for the next academic session, well within time preferably by 15th April, 2021, so that necessary adjustments and needful be done accordingly.

The respective detailed orders containing ten pages be kept with the record and copy of the orders be forwarded to the Principals of all the Medical Colleges above named and the Principal Secretary, Department of Health for needful.


