It is also noticed that inadvertently details of excess fee, being realized by Buddha Institute of Dental Sciences and Hospital, Patna with respect to M.D.S. courses, could not be mentioned in Agenda/Resolution No.05 dated 22.12.2020. The same has been incorporated above in today's Agenda/Resolution No.03. So, further reproduction here is needless, and the State Government is hereby requested to monitor the implementation of all the decisions taken by the Committee and take due step in the light of the aforesaid comparative chart as indicated in Agenda No.03.
