Agenda wise following resolutions are taken:-

**Agenda No.1:-**

Confirmation of the proceedings of the previous meeting dated 23.08.2023.

**Agenda No.03:-**

To consider and discuss the materials related to the proposal for fixation of fee for the session 2023-24 submitted by RDJMMCH, Turki, Muzaffarpur and pass necessary orders, which had been reserved during previous hearing, i.e., on 23.08.2023.

After over all consideration of the materials available, the comments of the Working Group relating to income and expenditure, etc., and hearing the college authorities, besides considering the written submissions, in anticipation of permission of renewal granted by NMC, in response of the request of the college

made on 04.08.2023, the fee for Under Graduate Degree course per annum considering the inflation at the rate of 7.44% is fixed by the committee at Rs.7.57 Lac including the development fee for the batch 2023-28 excluding hostel, mess charges and transportation to non-residents in hostel. However, it is made clear that the college cannot realize the amounts more than what they have already mentioned in their proposal .

The Committee directs that the institution shall not charge as directly or indirectly any other amount over and above the amount fixed as fee and if any other amount is charged under any other head or guise that is donation, fee by any other name the same would amount to charging of capitation fee. Any deviation of this order of the Committee will invite serious consequences.

It is further made clear that since the college has prayed NMC on 04.08.2023 to grant permission for admission into academic session 2023-24 but the matter is still pending, hence subject to the permission being granted by NMC for intake of the students for the academic year 2023-24 only, the above fee has been fixed only for the said batch for the period 4.5 years.

It is further strictly made clear that the college is supposed to pay due respect to the order of the Hon'ble Court dated 03.08.2023 passed in CWJC No.10903 of 2023 , paragraph No. 19 of which reads as such:-

“ This Court would, however, make it clear that further process taken by the petitioner towards admission of the students would be subject to result of the writ application and this should be made known to the students.”

It is expected that the college authorities will be particular in future and submit their proposal for fixation of the fee of the students for the next academic year well within time even in anticipation of the renewal or allotting

letter of permission as the case may be from NMC or simultaneous with the initiation of process by them for renewal, etc.


- (i) Relating to framing of Rules


All the three agendas were taken together and as assured by Sri Sanjay Kumar Singh, In-charge Member Secretary, concrete information is expected within a fortnight.
