It is for the Government on finding any violation of the recommendations of the Committee and notification of the Government by the colleges concerned to take due step and issue necessary directions in view of the decision of the apex court in case of Narayana Medical College vs. State of Andhra Pradesh and others reported in (2023) 2 Supreme Court Cases 636. The O.S.D. shall send all the materials collected after resolution dated 04.01.2023 aforesaid immediately to the Government authorities for needful.

Medical College & Hospital Turki, Muzaffarpur (ii) Lord Buddha Koshi Medical College & Hospital, Saharsa (iii) Shree Narayan Medical Institute & Hospital Mahabir Nagar, Bherdhari, Sharsa (iv) Madhubani Medical College, Madhubani and (v) Netaji Subhas Medical College & Hospital, Bihta, Patna and for fixation of the fee for the session 2022-23.

To consider the applications dated 28.06.2022 and 17.12.2022 of RDJM College, and Hospital, Turki, Muzaffarpur respectively received on 01.07.2022 and 30.12.2022 seeking revision of the fee fixed by the Committee for the session 2021-22 and pass necessary order after hearing the authorized representatives of the colleges at 11.30 A.M.

After hearing the representatives of the college finding no substance in the application dated 01.07.2022/17.12.2022 seeking review of the order passed on 22.06.2022 by the Committee stands disposed of. However, there is no order as to costs. The detailed reason orders containing 13 (Thirteen) Pages be kept in file after communication to all concerned under the signatures of Dr. Ranjeet Kumar Sinha, OSD

Agenda No. 07

To consider the maintainability of the submission of the proposals for fixation of the fee for the batch 2022-23 at belated stage after taking admissions by the respective colleges, namely, (i) R.D.J.M. Medical College & Hospital Turki, Muzaffarpur (ii) Lord Buddha Koshi Medical College & Hospital, Saharsa (iii) Shree Narayan Medical Institute & Hospital Mahabir Nagar, Bherdhari, Sharsa, (iv) Madhubani Medical College, Madhubani and (v) Netaji Subhas Medical College & Hospital, Bihta, Patna and pass necessary orders after hearing the authorized representatives of the colleges aforesaid.

On over all consideration and hearing the representatives of the colleges, the proposals submitted beyond the prescribed, in fact, after taking admission of the students in the respective colleges under law cannot be considered. Consequently turned down as not acceptable or entertainable but at the same

time, the Committee is bound under law to fix the fee on the basis of the materials available.

Accordingly, on the basis of the materials available, the comments of the Working Group relating to income and expenditure, etc., the fee for Under Graduate degree course per annum for the batch 2022-27 considering inflation @ 7.79% is respectively fixed for the colleges, namely, (i) R.D.J.M. Medical College_& Hospital Turki, Muzaffarpur at Rs.7.98 Lac, (ii) Lord Buddha Koshi Medical_College & Hospital, Saharsa at Rs.8.50 Lac (iii) Shree Narayan Medical Institute &_Hospital Mahabir Nagar, Bherdhari, Shars at Rs.09 Lac, (iv) Madhubani Medical_College, Madhubani at Rs.9.53 Lac and (v) Netaji Subhas Medical College &_Hospital, Bihta, Patna at Rs.15.50 Lac including the development fee, but excluding hostel, mess charges and transportation to non-residents in hostel. However, it is made clear that the colleges cannot realize amount more than what they have already mentioned in the respective proposals.

Since the college has already taken admission and realized fee from the students which is in excess of the amount fixed above, consequently the difference amount is to be refunded to the students by the college directly in their bank accounts strictly within 30 days from today, failing which they have to pay 9% interest upon the amount, if paid, within next 30 days, i.e., within 60 days from today. In the event of failure, the College will be liable to pay compound interest @ 18% till the date of actual payment. It is expected that the college will make this Committee aware of the compliance at the earliest.

The Committee directs that the institution shall not charge as directly or indirectly any other amount over and above the amount fixed as fee and if any other amount is charged under any other head or guise that is donations, fee by any other name the same would amount to charging of capitation fee. Any deviation of this order of the committee will invite serious consequences.

It is further made clear that since the college has been granted permission for intake of the students for the academic year 2022-23 only, the above fee has been fixed only for the said batch for the period of 4.5 years.

(i) It is pointed out by the Chairman that none of the Medical and Dental Colleges, while submitting its fee structure before the Bihar Combined Entrance Competitive Examination Board, mentions about the fee either fixed by the Committee or proposal submitted by it.

Resolution:

The Members of the Committee were shocked to learn such ignorance/negligence on the part of the colleges as well as BCECE Board and it is resolved to request the State Government to issue necessary directions to all concerned to be particular about the fee fixed by the Committee or status of the proposal, if any, submitted by the Medical or Dental Colleges as the case may be.

It is also expected that this Committee shall be made aware simultaneously about such directions issued. Meanwhile it is further resolved that for information and needful copy of this proceeding be also sent to the Controller of Examination, BCECE Board, Patna.

(ii) It is noticed that counselling for admission in MBBS course for the batch 2023-24 has started and process of scrutiny and verification of the documents related to the proposals submitted by the concerned private colleges has also been completed and the report of the Working Group is likely to be submitted within a week.

In view of the above it is resolved to held next meeting on 23.08.2023 at 11.00 A.M. Meanwhile, all concerned be intimated accordingly.
