04. To consider and discuss the prayer seeking rectification in order dated 15.10.2024 by Netaji Subhas Medical College & Hospital through reference nos. (i) NSMCH/Pri/467/2024 dated 18.10.2024 received through mail at 04:46 P.M. (ii) NSMCH/Pri/491/2024 dated 12.11.2024 and pass necessary order. it appears that in the order dated 15.10.2024 the fee fixed for MS. Anatomy is RS. 20,00,000/- instead of Rs. 2,00,000/- similarly for MS Obstetrics & Gynaecology for NRI USD 2,27,000/- instead of 1,17,000/- as submitted in the revised proposal of the college and also appears in the proceeding of the day. The typing errors in the concerned order be, accordingly, rectified. Let after necessary correction made in the order dated 15.10.2024, the college and all concerned be accordingly informed under the signature of Dr. Ranjeet Kumar Sinha, OSD and two pages original be kept in the file.

05. To consider and discuss the prayer of RDJMMC and Hospital, Muzaffarpur in pursuance of the order dated 20.09.2024 passed by the Hon'ble Patna High Court in C.W.J.C. No. 11213 of 2023, seeking review and setting aside order of the Committee dated 19.09.2024 vide reference no. JMI/RDJMMCH/FFC/144/2024-25 dated 10.10.2024 received through mail at 09:21 P.M. and after hearing the authority of the college pass necessary orders.

After hearing the authorities of the college and on due consideration, the Committee passed 172 pages reasoned order which be kept with the file after communicating to all concerned under the signature of Dr. Ranjeet Kumar Sinha, O.S.D., the operative portion of which is as follows:-

"On over all micro consideration of the materials available and hearing the authorities of the college, the committee finds no reason to change its conclusion already arrived at. Accordingly the representation of the college having no merit stands disposed of with expectation that the college will pay respect to the orders of Hon'ble the Supreme Court, placed and relied by the committee in its orders, just to refresh has been rementioned in para 11 here in above and it is also expected that the college if not complied orders of the committee, till date shall comply at once and intimated the committee for needful preferably within thirty days."

06. To consider and discuss the report of the Working Group with respect to the proposal submitted on 09.10.2024 vide ref. no. SDC/2024-25/8817 dated

08.10.2024 by Sarjug Dental College & Hospital & Mata R. Devi Dental Hospital and pass necessary orders.

On due consideration, the Committee passed 12 pages reasoned order which be kept with the file after communicating to all concerned under the signature of Dr. Ranjeet Kumar Sinha, O.S.D., the operative portion of which is as follows:-

"Since the above revised proposal of the college is much nearer to the conclusion of the committee, hence acceptable. Consequently, there appears no need to invite the college authorities for hearing rather accepting the revised proposal the fee for Under Graduate BDS course for session 2024-28, is hereby fixed at Rs. 3.35 lacs per annum excluding Hostel & Mess charges but on the above heads the college shall not realise the amount more than what has been mentioned in the revised proposal."

07. To consider and discuss the report of the Working Group with respect to the information given on 06.11.2024 vide ref. no. LBKMCH/742-24 dated 05.11.2024 by Lord Buddha Koshi Medical College & Hospital about the enhancement of seats from 100 to 150 by NMC for current session and pass necessary orders.

On due consideration, the Committee passed 06 pages reasoned order which be kept with the file after communicating to all concerned under the signature of Dr. Ranjeet Kumar Sinha, O.S.D., the operative portion of which is as follows:-

"On overall consideration, the Committee for the present finds no reason to change the fee of MBBS course for the session 2024-29 for the enhanced 50 seats. Accordingly, the proposal of the college is accepted as Rs.11.75 Lac and the terms and conditions imposed in the previous order shall equally be applicable to the increased seats." 08. Any other point or points under the permission of the Hon'ble Chairman.

It is noticed that on the medical ground Office Manager, Shri Vijay Prasad Sinha, was absent from 22.10.2024 to 28.11.2024. Since during absence of the Office Manager work load of Shri Anil Kumar Shrivastava Office Assistant and Shri Vinod Kumar Pandit Data Entry Operator had been substantially increased hence, they deserve to be monetarily compensated. Accordingly, in addition to their remuneration, they are to be paid Rs.3,500/- each as incentive during the period of absence of the Office Manager from 22.10.2024 to 28.11.2024.
