To consider and discuss the report of the Working Group with respect to the revised proposal submitted by Netaji Subhas Medical College and Hospital, Amhara, Bihta, Patna on 04.11.2025 vide ref. No.NSMCH/PRI/519/2025 dated 03.11.2025 with respect to enhanced 50 seats for MBBS course for the session 2025-26.

On due consideration the Committee passed 40 pages reasoned order which be kept with the file after communicating to all concerned under the signature of Dr. Ranjeet Kumar Sinha, OSD., the operative portion of which is as follows:-

On overall consideration of the materials, the fee for all 150 seats for Under Graduate Degree course per annum for the batch 2025-26 considering inflation @ 3.16 % including the development fee excluding hostel, mess charges and transport to non-residents in hostel is fixed by the Committee for residents Indian at Rs.15.90 Lacs and for NRI USD 35,000. Accordingly, the above revised proposal of the college is accepted, and the previous order of the Committee dated 25.07.2025 stands modified to the extent stated above.

However, it is made clear that the college authorities cannot realize the amount in the above heads more than what they have already mentioned in their revised proposal.

The Committee directs that the Institution shall not charge directly or indirectly any other amount over and above the amount fixed as fee and if any other amount is charged under any other head or guise, i.e., donation, fee for any other head, the same would amount to charging of capitation fee. Any deviation of the order of the Committee will invite serious consequences.

To consider and discuss the report of the Working Group with respect to the revised proposal submitted by Himalya Medical College and Hospital, Chiksi, Paliganj, Patna submitted vide ref. No. HMCH/697/25 dated 16.10.2025 with respect to enhanced 50 seats for MBBS course for the session 2025-26.

On due consideration the Committee passed 27 pages reasoned order which be kept with the file after communicating to all concerned, under the signature of Dr. Ranjeet Kumar Sinha, OSD., the operative portion of which is as follows:-

On overall consideration of the materials, the fee for all 150 seats for Under Graduate Course per annum for the batch 2025-26 considering inflation @ 3.16 % including the

development fee excluding hostel, mess charges and transport to non-residents in hostel is fixed by the Committee for residents Indian at Rs.15.40 Lacs and for NRIs USD 27,000/-. Accordingly, the proposal of the college is accepted and the previous order of the Committee dated 19.08.2025 stands modified to the extent stated above.

However, it is made clear that the college authorities cannot realize the amount in the above heads more than what they have already mentioned in their revised proposal.

The Committee directs that the Institution shall not charge directly or indirectly any other amount over and above the amount fixed as fee and if any other amount is charged under any other head or guise, i.e., donation, fee for any other head, the same would amount to charging of capitation fee. Any deviation of the order of the Committee will invite serious consequences.

To consider and discuss the report of the Working Group with respect to the proposal submitted by Viraat Ramayan Institute of Medical Sciences, VPO Koyala Belwa P.S. Chakiya, District- East Champaran with respect to 50 seats for MBBS course for the session 2025-26

On due consideration the Committee passed 14 pages reasoned order which be kept with the file after communicating to all concerned, including NMC under the signature of Dr. Ranjeet Kumar Sinha, OSD., the operative portion of which is as follows:-

On overall consideration of the materials, the fee of all 50 seats for Under Graduate Course per annum for the batch 2025-26 considering inflation @3.16% including the development fee excluding hostel, mess charges and transport to non-residents in hostel is fixed by the Committee for residents Indian at Rs.16 Lacs and for NRIS USD 28,000. Accordingly, the proposal of the college is accepted to the extent stated above.

However, it is made clear that the college authorities cannot realize the amount in the above heads more than what they have already mentioned in their revised proposal.

The Committee directs that the Institution shall not charge directly or indirectly any other amount over and above the amount fixed as fee and if any other amount is charged under any other head or guise, i.e., donation, fee for any other head, the same would amount to charging of capitation fee. Any deviation of the order of the Committee will invite serious consequences.




Any other point or points under the permission of the Hon'ble Chairman.
