

- (i) Relating to appointment of an Office Assistant on the second sanctioned post.

04. To consider and discuss the report of the Working Group with respect to the proposals submitted on 30.12.2024 vide Ref No. LBKMCH 440-443-446/24 dated 29.12.2024 and the revised proposal dated 19.02.2024 by Lord Buddha Koshi Medical College and Hospital, Saharsa.

On due consideration the Committee passed 13 pages reasoned order which be kept with the file after communicating to all concerned under the signature of Dr. Ranjeet Kumar Sinha, OSD., the operative portion of which is as follows:-

The above revised proposal, which was under consideration since before during inter se discussions among the Members, seems nearer to the tentative conclusion arrived by the Members. Consequently, the revised proposal dated 19.02.2025 is accepted and the fee for the session 2024-25 MS/MD course, as detailed below, is fixed :-

for NRI only for MD Radiology USD 102,400.00, per annum excluding Hostel & Mess Charges but the college will not charge any amount under the above head more than what is proposed in revised proposal as mentioned in para-09 of the order.

The Committee further directs that the institution shall not charge either directly or indirectly any other amount over and above the amount fixed as fee and if any other amount is charged under any other head or guise that is donations, fee by any other name the same would amount to charging of capitation fee. Any deviation of this order of the committee will invite serious consequences.



**Agenda No.05.**

05. To consider and discuss the report of the Working Group with respect to the proposal submitted on 09.01.2025 vide Ref. No.5055/25 dated 08.01.2025 and the revised proposal dated 20.02.2025 by Madhubani Medical College, Madhubani and pass necessary orders.

On due consideration the Committee passed 11 pages reasoned order which be kept with the file after communicating to all concerned under the signature of Dr. Ranjeet Kumar Sinha, OSD., the operative portion of which is as follows:-

The above revised proposal, which was under consideration since before during inter se discussions among the Members, seems nearer to the tentative conclusion arrived by the Members. Consequently, the revised proposal of the college submitted on 20.02.2025 is accepted and fee per annum for MS Otorhinolaryngology for the batch 2024-27 is fixed Rs.12 Lacs for resident Indian and 22,000 USD for NRI excluding hostel and mess charges but the college will not charge any amount under the above head more than what is proposed in revised proposal as mentioned in para- 09 of the order.

The Committee further directs that the institution shall not charge either directly or indirectly any other amount over and above the amount fixed as fee and if any other amount is charged under any other head or guise that is donations, fee by any other name the same would amount to charging of capitation fee. Any deviation of this order of the committee will invite serious consequences.

- (i) The Committee is shocked due to non-completion of the process of fixation of fee with respect to Mithila Minority Dental College and Hospital, Darbhanga, R.D.J.M Medical College and Hospital, Turki, Muzaffarpur, Madhubani Medical College, Madhubani, Netaji Subhas Medical College and Hospital, Bihta, Patna, Shree Narayan Medical Institute and Hospital, Saharsa and Lord Buddha Koshi Medical College and Hospital, Saharsa only because the laches on the part of the respective colleges which caused delay in submission of their proposals and furnishing complete supporting documents.

It is considered opinion of the Committee that the Member Secretary in his official capacity should take initiative so that in future no such occasion may arise.

- (ii) It is also shocking that in spite of due information a few colleges such as, Himalaya Medical College and Hospital, Chiksi, Paliganj, Patna, Katihar Medical College, Katihar, Narayan Medical College and Hospita, Jamuhar Rohtas and M.G.M. Medical College and Hospital, Kishanganj have not yet submitted their proposals before the Committee.

It is also supposed that the Member Secretary shall in his official capacity also look into the matter.



- (iii) Since the proposals submitted by the colleges as above para (i) are under active consideration/scrutiny of the Working Group, which assures to submit its reports on or before 23<sup>rd</sup> July, 2025.

In view of the above and commencement of the counselling for admission, the Members of the Committee shall be meeting to consider the reports, etc. and decide the respective fees at 11.30 A.M. on Friday (25.07.2025).
