## Agenda No.04

To consider and discuss the report of the Working Committee with respect to the proposal submitted by Himalaya Medical College & Hospital, Chiksi, Paliganj, Patna on 04.08.2025 with respect to MBBS course for the session 2025-26 for 100 seats with Ref. No. HMCH/497 dated 12.07.2025 and after hearing the authorities of the college pass necessary orders.

On due consideration the Committee passed 42 pages reasoned order which be kept with the file after communicating to all concerned under the signature of Dr. Ranjeet Kumar Sinha, OSD., the operative portion of which is as follows:-

After overall consideration of the materials available, comments of the working group relating to income and expenditure as well as the revised proposal, submitted today which appears nearing the tentative conclusion of the Committee, the fee for under Graduate degree course per annum including development fee for the batch 2025-30 excluding hostel and mess charges as the college does not claim any transport charge, subject to decision of the Hon'ble court is fixed by the Committee (i) On all the seats for residents Indian at Rs. 15,50,000/- and for non-



resident Indians at USD 27,000/- (ii) after Government quota on 50% of the seats for the remaining seats for residents Indian at Rs. 30,00,000/- and for Non-Resident Indians at USD 45,000/- However, it is made clear that the college authorities cannot realize the amount more than what they have already mentioned in their proposal submitted before the Committee under above heads.

The Committee directs that the institution shall not charge either directly or indirectly any other amount over and above the amount fixed as fee and if any other amount is charged under any other head or guise that is donations, fee by any other name the same would amount to charging of capitation fee. Any deviation of this order of the committee will invite serious consequences.

It is further made clear that since the college has been granted permission by the NMC for intake of the students for the academic year 2025-26 only, the above fee has been fixed only for the said batch for the period of 4.5 years.

## Agenda No.05

To consider and discuss the report of the Working Committee with respect to the proposal submitted by R.D.J.M Medical College & Hospital, Manaria Chhajan, Turki, Muzaffarpur on 01.08.2025 with respect to enhancement of fee for MBBS course for the session 2025-26 in the light of Government notification relating to allotment of 50% seats to the Government quota, with Ref. No. RDJMMCH/P.O/486/2025-26 dated 01.2025 and after hearing the authorities of the college pass necessary orders.

On due consideration the Committee passed 21 pages reasoned order which be kept with the file after communicating to all concerned, including NMC under the signature of Dr. Ranjeet Kumar Sinha, OSD., the operative portion of which is as follows:-



In view of the above and inter se discussions it was not required to call the authority of the college for any hearing but at the same time, the committee can not stop, itself from saying that, had the college earlier submitted its letter to withdraw, wastage of time and energy of the committee, could have been avoided. Such type of playing games with the committee must not be tolerated, the Government of

Bihar and NMC are supposed to take care of and insert in the rule penal clause against such wrong dower.

However, it is pertinent to mention that Dr. Santhosh Kumar Kraleti express his inability to attend to meeting and likewise the member secretary due to official engagement sent Mr. Dinesh Kumar Jha, Joint Secretary to represent him. After over all consideration of the materials available, comments of the Working Group etc. The committee is decided that in the event the college comes in future for any order from the committee relating to 50% seats for Under Graduate degree course 2025-30, subject to decision of the Hon'ble court, the materials discussed above may be used as guiding factor, with the above observations application dated 01.08.2025 of the college stands disposed off.
