
Agenda No.03

As said by Mr. Dinesh Kumar Jha, matter is pending with Law Department.

- (ii) Accommodation and infrastructure for the Committee.



As said by Mr. Dinesh Kumar Jha, reminder has been sent to Executive Director, State Health Society but in view of his letter address to the OSD Letter No. 4378 dated 01.09.2025 fresh steps is required to be taken and he assures to do the needful.

- (iii) The action taken by the Government of Bihar and NMC with respect to RDJM Medical College & Hospital, Turki, Muzaffarpur in the light of letter No.Sa.Sa.-1/Vividh-13/2017-262 (1) dated 15.05.2024 and letter No. 524 (Ka) dated 09th September, 2024 and order dated 25.07.2025.

Mr. Dinesh Kumar Jha, while pointing out Letter No. 1179(1) dated 10.12.2025 submitted that steps have already taken, compliance report from concerned college is awaited.

- (iv) Relating to the notifications to be issued by the State of Bihar with respect to the fee for U.G. and P.G. As submitted by Mr. Jha matter is still pending with the highest authorities.

- (v) Relating to the status of L.P.A No. 1096 of 2024 and the action taken if any with respect to C.W.J.C No. 13742 of 2023 in view of Agenda resolution no. 6 dated 17.07.2025.

It is said that through letter no. 1206 (1) dated 22.12.2025 GP 12 has already been requested for the needful. Outcome is awaited.

Mr. Jha also intimated that through letter no. 1205 (1) dated 22.12.2025 SC-23 has already been requested to expedite hearing of CWJC No. 13742/2023 related with Madhubani Medical College in the light of Order dated 24.09.2025 passed in said writ staying Operation of Order dated 08.08.2023 of this Committee.


04. To consider and discuss the report of the Working Group with respect to the revised proposal submitted by Madhubani Medical College, Madhubani on 01.12.2025 vide Ref. No. 6968 dated 29.11.2025 with respect to enhanced 100 seats for MBBS course for the session 2025-26 as well as the proposal submitted vide Ref.No.6475/25 dated 02.09.2025 received on 19.09.2025 with respect to fee fixation for various PG courses for the batch 2025-28 and after hearing the college authorities pass necessary orders.

On due consideration the Committee passed 47 pages reasoned order which be kept with the file after communicating to all concerned under the signature of Dr. Ranjeet Kumar Sinha, OSD., the operative portion of which is as follows:-

After overall consideration of the materials available, comments of the Working Group relating to income and expenditure etc. And overall submission made by college including the revised proposal wherein unsuccessful attempt appears made on behalf of the college tuition fee including development fee for Under Graduate course per annum considering inflation @ 3.16% is fixed by the committee for all 250 seats for resident Indians @ Rs. 13,00,000/- and for NRI USD 30,000 for the batch 2025-30 excluding Hostel and Mess charges.

Accordingly, earlier order of the committee dated 25.07.2025 related only with UG course stands modified to extent stated above.

So far revised proposal for PG course appears nearing the tentative conclusion of the committee, it is accepted to the extent the committee fixed subject wise fee for the Post Graduate course per annum for MS/MD courses. Considering the inflation @ 3.16% including development fee for the batch 2025-28 excluding Hostel and Mess charges as per details below:-







