After overall consideration of the materials available, comments of the working group relating to income and expenditure, etc., and overall submissions made by the authorities of the college the fee for Under Graduate Degree course per annum considering inflation at the rate of 4.38% is fixed by the Committee at Rs.15.50 Lacs for resident candidates and USD 27,000 for NRI's including development fee and Rs. 2.75 lacs for hostel and mess charges for both categories for the batch 2026-31.

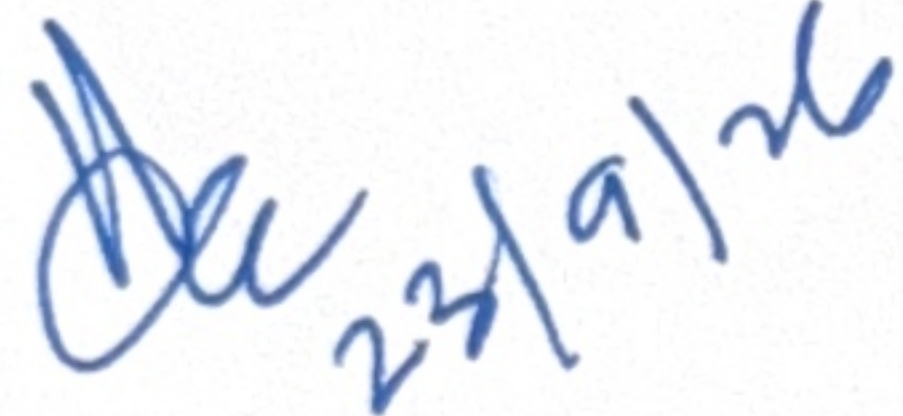

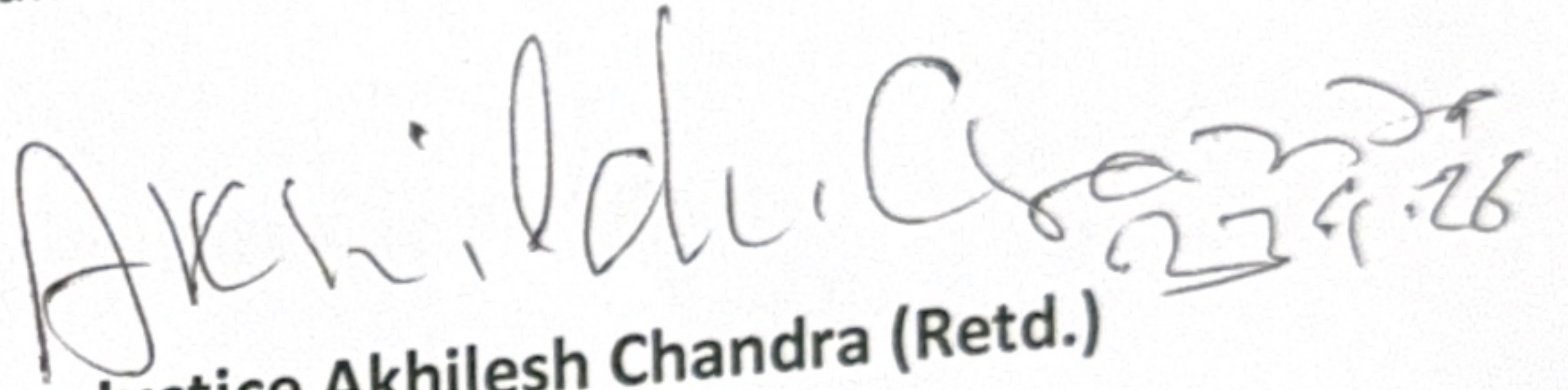
